



WELCOME TO THE SITE OF ACROBATIC COURSES AT HEIGHT IN THE NATURE: ACCROCHE AVENTURE

By buying units, a free entry, a pass to Accroche Aventure park or more simply as a visitor without practicing activities, you accept all of this regulation's clauses. All visitors must present themselves at the reception before any walk. Your responsibility may be called into question if you have contravened the rules and provisions appearing in these internal regulations. Accroche Aventure reserves the right to exclude, without any right to any refund, any person who behaves dangerously for themselves or for others and / or who does not respect these rules. Accroche Aventure assumes no responsibility in case of non-compliance with the safety instructions or these internal regulations.

THE PARK'S INTERNAL RULES:

1-Courses in height :

The acrobatic course in height is a fun activity space allowing the practitioner to walk in height independently and more or less acrobatic, on and between the trees. It is made up of workshops divided into several courses distinguished by specific color codes. Respect the trees by always staying on marked paths so as not to bruise the roots of the trees by compacting the ground. This activity is autonomous. It is not properly supervised. It is tracked from the ground by staff, recognizable by their green clothes. Accroche Aventure can't be held responsible for the deterioration or loss of the personal effects of customers such as people accompanying him or even on a stroll on the site or objects that are entrusted to him at the reception or park staff

In peak times (July / August), the management reserves the right to restrict the activity at 3 hours.

2- Respect the environment :

The forest is a fragile environment, the trampling of the ground degrades the vegetation and kills trees. The participants agree with the respect of the environment (trees, fauna, flora) and stay on the marked paths. It is forbidden to go beyond the cords delimiting these paths.

Please bring your waste to the trash next to the reception.

It is reminded that it is forbidden to smoke in the park whether on the courses, on the ground, at the time of the picnic break, a space provided at the reception is dedicated to smokers for the safety of all and the fire prevention.

3-Right of access to the courses and entry to the site:

A right of access to the course, the supply and installation of the practitioners' equipment, the description of the activity and the safety and uses instructions for the equipment, the application on a test course for validation by an operator and any surveillance, advice and / or help during the session.

The fact of carrying out a course partially or not at all gives no right to any refund. Any route started, followed by abandonment for any reason, will not be refunded. The same is true if a practitioner is arrested by an operator for safety reasons. The site is also accessible free of charge to visitors accompanying practitioners, provided that they comply with all the clauses of these regulations.

Visitors and accompanying persons must respect the instructions of the operators, not exceed the safety limits, do not prevent operators from giving instructions to practitioners. In the event of a storm or strong wind, practitioners could be asked to descend from the courses. In this one case, if the weather does not allow a continuation of the activity in the hours which follow, new tickets will be given for a future service to be valid in the current calendar year; no reimbursement may be required.

4- Conditions of access to the heights courses

Adopt in all circumstances a responsible and prudent behavior.

To have paid an entrance fee at the reception before accessing the facilities.

To have benefited from the explanations of the safety instructions at beginning of session (briefing)

Being in good health, and not being affected by any physical disorder (heart disorder, back, spine, dizziness, activity strongly discouraged for pregnant women ...), nor psychic. The practice is prohibited for anyone who has consumed alcohol or any substance (narcotic or medication) which may impair their ability and / or alertness.



Have subscribed, beforehand, individual insurance in civil liability.

Respect the age and support conditions indicated in chapter 5 of these regulations

Smoking is prohibited throughout the park. The Management reserves the right to refuse access or to exclude any person it considers does not meet the above conditions.

5- Age conditions and support:

For individuals, support for children must be carried out as follows:

- Children from 3 to 5 years old: Children must be accompanied by an adult on the courses. (Preferential rate)
- For children who are used to coming and practicing the activity, visual surveillance by an adult responsible for the soil will be sufficient.
- Children from 6 to 16 years old must be accompanied by a responsible adult during registration. The latter must remain present for all the activity.
- Groups of minors (schools and communities) must provide sufficient supervision taking into account the specificity of the activity and the age of the practitioners.

Generally, customers must comply with all of the instructions and directives given.

6- Security:

YOU ARE RESPONSIBLE FOR YOUR OWN SECURITY, YOU PERFORM THE DIFFERENT COURSES IN AUTONOMOUS PRACTICE

1. Provide jogging pants, sneakers. Avoid shorts, sleeveless t-shirts and tie long hair. Flip flops prohibited.
2. The participant must take all measures to avoid any accident, tie the hair to avoid the risk of tearing in the pulley, empty his pockets (risk of falling objects), remove personal effects which can represent a danger during the activity (jewelry, piercing, bags, laces, cameras...).
3. Each customer is equipped by our operators with safety equipment provided by Accroche Aventure and checked before each departure. Only official Accroche Aventure's equipment is authorized and compatible with the facilities.
4. Practitioners must respect the instructions for using the workshops, the specific instructions for progress, respect the number of people authorized per workshop and platform and all the directives given during the briefing.
5. Participants must attend the security briefing. It makes it possible to show and put into practice safety rules and adaptation to the material. They must also pass the test course to put these safety instructions into practice and test their abilities. Anyone who, at the end of the briefing and the test course, does not feel able, physically or morally, to carry out alone correctly the manipulations essential for an evolution in self-insurance (independently) must give up the activity. Staff reserves the right to refuse access to anyone who does not have the necessary physical or motor skills on these training courses.
6. The participant is responsible for observing the safety instructions and must constantly ensure his personal movement in the trees while remaining permanently connected to the lifelines.
7. The practitioner keeps his equipment throughout the course and does not lend it to anyone and must in no case remove and / or return his equipment without the control of an operator.
8. In the event of a problem, please notify the park staff by any useful means. All staff have been trained to meet service and safety requirements.
9. Always stay on marked paths. It is forbidden to cross the boundaries of marked paths (cords). Exercise vigilance and caution not to park near workshops and / or zip lines arriving on the ground.
10. It is strictly forbidden to interrupt and / or leave a course without the authorization and assistance of an operator.



7- Opening hours and access:

Access to the park is authorized, only during park opening hours, it is reserved for practitioners and their companions. Access is strictly prohibited outside the opening hours.

Access to routes at height is strictly prohibited outside opening hours (unsecured and unsupervised installations) and without authorization from the management.

8- Insurance:

Accroche Aventure, SARL with a capital of 5,000 €, domiciled in St Julien Peyrolas (30760), contracts professional liability insurance with C.G.B Assurances and Property Damage insurance with Allianz Assurance.

The courses are subject to annual technical control, carried out by the company SEREC, and to annual forest control, carried out by the AVAL. Regular controls are carried out by the direction, any anomaly being recorded in a dedicated notebook. In the event of litigation, only the court of Nîmes is judged competent.

Anyone present on the site is deemed to have taken out civil liability insurance and individual accident insurance. Groups of minors (schools and communities) must provide sufficient supervision taking into account the specificity of the activity and the age of the practitioners.

9- Identification and personnel's qualifications :

Accroche Aventure staff (operators) can be identified by green t-shirts (or jackets) with the Accroche Aventure logo and name. The operators were trained according to a training program provided by AFFORPAH. The Operators have all followed an adapted training which is validated by a Professional Qualification Certificate for Operators of Acrobatic Course in Height (CQPOPAH).
